It coordinates rides to medical and related appointments for frail older adults, people with disabilities and low income residents in Westchester County, New York and Fairfield County, Connecticut. It maintains a call center and a central directory of transportation resources, which it makes available to community partners online and by phone.

WestFair Rides achieves its mission by:

1. Providing information and referrals to ride alternatives for older adults and visually impaired adults,
2. Mobilizing volunteer drivers to transport older adult and visually impaired adults to medical appointments,
3. Arranging other service to provide rides when WestFair volunteers cannot,

5. Consulting with town and nonprofit organizations that wish to startup their own volunteer ride programs.

Form 990, Part VI, Section 12b. All members of the Board of Directors must disclose any

potential conflicts of interest on an ongoing basis. In addition an annual statement is filed

by each board member.

Form 990, Part VI, Section B, Line 15a: To determine compensation of employees the Board of

Directors researches the range of compensation for comparable positions in similarly-sized

nonprofit organizations in the area and develops a salary range for the position. The specific

salary is then determined by taking into account the individual's experience, qualifications,

performance evaluations and achieved goals.
